Approval of Minutes

Chairman Walker called for approval of the April 14, 2026, Regular Meeting Minutes. It was moved by Dan Hanson, seconded by John Pettyjohn to approve said Minutes. Roll was called on the motion with the following results. Board Members voting aye: Hanson, Fitzgerald, Lake, and Pettyjohn. Chairman Walker abstained. Motion carried.

New Business

Chairman Walker asked David Strickland to update the Board about the code adoption for the 2026 NEC (National Electric Code). He stated it was a requirement of the State to adopt this Code. Chairman Walker called for a motion to move forward with the 2026 NEC Code adoption. It was moved by Dan Hanson, seconded by Keenan Fitzgerald. David had given the Board a packet of some of the significant changes to the Code. He stated they could review it and discuss the changes. He stated it is on pace to be in place by July 1, 2026. Gregg Lasse explained that the state statute gives local authority to the City of Gillette, for example, to adopt the Codes as the State adopts them. He stated the NEC (National Electric Code) is adopted automatically by the State and they will start enforcing it the first of July 2026. The statute requires that the City adopt it within 6 months after that date and failure to do so would revert jurisdiction back to the State.

Roll was called with the following results. Board Members voting aye: Pettyjohn, Hanson, Fitzgerald, Lake, and Chairman Walker. Motion carried.


Chairman Walker asked David if there was any information about when the fee ordinance will come back around. He encouraged the Board members to talk to their City Council members and ask them to see it again.
