**ORDER ADOPTING A REVISED CITY OF GILLETTE'S UNIFORM
BAIL AND FORFEITURE SCHEDULE**

This Court, pursuant to City Code 16-1, having reviewed the previous bond and forfeiture schedules previously ordered by this Court, finds that the attached revised City of Gillette Uniform Bail and Forfeiture Schedule should be adopted. It is therefore,

ORDERED that the revised City of Gillette Uniform Bail and Forfeiture Schedule, as attached, shall be, and hereby is, adopted and shall become effective March 1, 2025.

FURTHER ORDERED that the State of Wyoming Revised Uniform Bail and Forfeiture Schedule, as adopted by the Wyoming Supreme Court on April 30, 2024, shall be adopted in whole and shall apply to all traffic offenses contained in Wyoming Statute and adopted in City Code 11-1. Further, violations of City Code 11-4(a) & (b) (Speed Limits) shall have a bond set as established by the equivalent violation of State statute. Any further modifications of the State of Wyoming Revised Uniform Bail and Forfeiture Schedule shall hereby be adopted and ordered. Any disparity between fees and costs set for circuit courts and those established for municipal courts shall be reflected in the fines assessed.

AND IT IS FINALLY ORDERED that copies of this Order and the City of Gillette's Uniform Bail and Forfeiture Schedule shall be distributed to all interested parties. This Order and the City of Gillette's Uniform Bail and Forfeiture Schedule shall also be published on the Municipal Court website.

City of Gillette
Uniform Bail and Forfeiture Schedules
Pursuant to Wyo.R.Cr.P 3.1 and City Code 16-1.

(Effective March 1, 2025)

The following schedule is being established and shall be used for misdemeanor violations of the Gillette City Code for which bond may be posted and forfeited.

The amount of bail listed shall include court costs of \$10.00, a court automation fee of \$40.00, and a \$10.00 indigent civil legal services fee. Violations of State traffic offenses shall include a \$5.00 law enforcement training fund fee.

OFFENSES INVOLVING A CRASH, WILL BE AT THE OFFICERS DISCRETION WHETHER IT IS MARKED AS MUST APPEAR OR BONDABLE. IF OFFICERS CANNOT DETERMINE IF INSURANCE IS VALID OR SUFFICIENT, MUST APPEAR IS REQUIRED TO BE MARKED.

FURTHER, ANYTHING NOT LISTED ON THE SCHEDULES ALSO SHALL BE CONSIDERED A MUST APPEAR CITATION.

IF THE "MAY FORFEIT BOND IN LIEU OF APPEARANCE" BOX IS CHECKED, THE PERSON HAS TWO OPTIONS:

1. APPEAR ON THE DAY AND THE TIME SPECIFIED ON THE CITATION
- OR
2. POST BOND AT OR PRIOR TO THE COURT DATE AND FORFEIT THE SAME IN LIEU OF THEIR APPEARANCE.

A PERSON TO WHOM THE CITATION HAS BEEN ISSUED **MUST APPEAR** IN COURT ON THE DAY AND AT THE TIME SPECIFIED IN THE CITATION UNLESS THE OFFICER CHECKS THE BOX "MAY FORFEIT BOND IN LIEU OF APPEARANCE" ON THE CITATION.
