- Please allow six to eight weeks to process your rebate request. A check will be mailed to the address you listed above.
- Irrigation system components purchased and installed by the customer for the rebate program are for their own use in the location listed above and shall not be resold or transferred to another property.
- The rebate check is for approved irrigation system components only. No other refunds or rebates will be issued as part of this specific program.
- The City of Gillette makes no representation or warranty that the homeowner will be satisfied with the performance of the irrigation system components.
- The City of Gillette assumes no liability for any loss, damage or expense connected to the materials, workmanship, or fitness of the irrigation system components; including installation of the irrigation system components.
- Homeowner hereby releases and agrees to hold harmless The City of Gillette and its employees from any all claims, losses, harms, costs, liabilities, damages, and expenses directly or indirectly resulting from or related to the irrigation system components.

For purposes of determining the water-saving effectiveness of this program, the City of Gillette will examine water use records of participating residences and businesses. The homeowner also agrees to allow City staff or their appointee to examine purchased equipment that has been installed.
